

Ready Airman Training (RAT) for IMAs

All IMAs are "Category 1 Reduced Risk Airmen" and Complete the Training in a Four-year Cycle

Airmen are expected to manage their own readiness training requirements and currencies. The IMA's Active Component (AC) Unit Deployment Manager (UDM) assists the IMA with scheduling required in-person training. The UDM ensures training is updated in the system of record. It is estimated that an IMA will spend a total of 25 hours over a four-year cycle performing RAT activities, some of which will be part of their normal duty activities. There are three requirements that members must attend in person (CBRN Defense Training, Tactical Casualty Combat Care, and Small Arms Qualification).

The IR Strategy Office's (ISO) goal is to improve the lived experience of all IMAs. The ISO created the following **SAMPLE** four-year schedule to maintain RAT currency for CAT 1 IMAs. There are many training options in each category. The chart below features a single scenario in which an IMA spends one IDT in the first quarter of each year for CBTs, attends an IR Call and Commanders Call, and attends one hands-on training three times in the four-year cycle. CBTs are located in My Learning in the Ready Airman Training module.
